- Lands owned by the grantor showing the boundaries and dimensions.
- The distance between the applicant's land the nearest Municipal lot line or appropriate landmark (e.g. road, bridge, railway crossing, etc.).
- The location of the entrance that is the subject of the application showing the boundaries and dimensions of the parcel that is to be serviced.
- The approximate location of all natural and proposed features on the subject land (e.g. buildings, railways, highways, watercourses, drainage ditches, wells and septic tanks).
- Entrance Application Fee and Deposit Required with Application:**  
Administration Fee: \$50.00 (Non-Refundable)  
Deposit: \$500.00 deposit for residential entrances which will be refunded upon final inspection and approval of the completed entrance by the Public Works Supervisor.  
\$1,000.00 deposit for commercial entrances which will be refunded upon final inspection and approval of the completed entrance by the Public Works Supervisor.
