- approximate location of all natural and artificial features that might affect the application (including roads, watercourses, railways, wooded areas) that are on subject lands and on lands adjacent to it.
- current uses of land that is adjacent to subject lands.
- location, width and names of roads within or abutting subject lands.
- indication whether roads are municipally maintained, unopened road allowance or right-of-way.
- location of parking and docking facilities if access by water.
- location and nature of any easements affecting subject lands.
