Kathy Scott and Jim Keniston attended the meeting to present to Council the festival summary report for the 2012 Tweed Tribute to Elvis Festival. The delegates provided information on the number of guests at the event and the TREIM (Tourism Region Economic Impact Model) statistics on revenue generated. A summary of comments from merchant and festival goers was presented, including positive improvements from the previous year, specific challenges faced and suggestions for next year. The delegates outlined the festival expenses and advised that admission sales and attendance were down slightly from the previous year. They advised of the festival successes including increases in camper and vendor registrations and early-bird online ticket sales.
