NOTICE OF APPLICATION and NOTICE OF PUBLIC MEETING CONCERNING A PROPOSED ZONING BY-LAW AMENDMENT

NOTICE is hereby given that the Council of the Municipality of Tweed has received an application for an amendment to Comprehensive Zoning By-Law No. 2012-30, complete with the prescribed information.

TAKE NOTICE that the Council of the Municipality of Tweed will hold a Public Meeting on **Wednesday, May 29, 2019 at 5:00 p.m.** in the Council Chambers at 255 Metcalf Street, Tweed to consider a proposed zoning by-law amendment under Section 34 of the Planning Act for the above noted application, numbered as ZA2/19.

The proposed zoning by-law amendment will change the zoning for the lands described as Part of Lots 13 and 14, Concession 6, Township of Hungerford, now the Municipality of Tweed and shown on the key map attached hereto.

The purpose and effect of the proposed zoning by-law amendment is to change the zoning of the land parcel as follows:

1. Two approx. 1.0 acre severed lots from the Mineral Extractive Reserve (MXR) zone to the Rural Residential (RR) zone to recognize the intended residential use.
2. A portion of an approx. 86.0 acre retained parcel from the Mineral Extractive Reserve (MXR) zone to the Rural (RU) zone as the existing aggregate is not feasible for extraction.

The portions of the subject land zoned Environmental Protection (EP) will remain zoned as such. The rezoning of the two severed lots to RR and the portion of the retained lands to RU is a condition of Severances B82/18 and B83/18 and will provide for the appropriate zoning for the size and use of the new parcels.

Additional information and material relating to the application for the proposed zoning by-law amendment is available for inspection by any member of the public during regular business hours at the Municipal Office, 255 Metcalf Street, Tweed.

ANY PERSON may attend the Public Meeting and/or make written or verbal representation either in support of or in opposition to the proposed zoning by-law amendment.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Municipality of Tweed to the Local Planning Appeal Tribunal but the person does not make oral submissions at the Public Meeting, or make written submissions to the Municipality of Tweed, before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at the Public Meeting, or make written submissions to the Municipality of Tweed, before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
